Mr. Millett made a motion, seconded by Mrs. Mackiw, that the monthly stipend for Mr. Tom James be set at \$600 per month to operate the High School sewer plant. The motion was approved by unanimous roll call vote 9-0.

Mr. Litwin made a motion, seconded by Mr. Saxton, that Mr. Richard Phillips be employed as a Maintenance II employee at the probationary rate of \$6.20 per hour, as per the negotiated agreement, effective June 17, 1989; and that Mr. Thomas Schofield be transferred to the newly created third shift Maintenance II position at the high school, effective August 28, 1989. Mr. Litwin made a motion, seconded by Mrs. Geeza, that Harry Powell be appointed to the position of Athletic Director for the Lackawanna Trail School District. The motion was approved by unanimous roll call vote 9-0.

Mr. Litwin made a motion, seconded by Mrs. Geeza, that the Superintendent's secretary receive an 8% salary increase equal to that granted the LTSSPA for the 1989 90 school year. The motion was approved by unanimous roll call vote 90.

Mr. Litwin made a motion, seconded by Mrs. Mackiw, that a leave without pay or benefits for child rearing purposes be granted to Linda White beginning August 7, 1989 to and including Friday, October 27, 1989. The motion was approved by unanimous roll call vote 9-0.

Mrs. Geeza made a motion, seconded by Mr. Millett, that the Collective Bargaining Agreement with the Lackawanna Trail Education Association, effective July 1, 1989 through and including June 30, 1993 be approved. The motion was approved by roll call vote 7-1-1. (Mackiw voting no - Seamans abstaining)
