- + Motion by Dr. Mould, Mr. Strauch that Treasurer's Report be approved as submitted.
- + Motion by Mr. Stark, Mr. Mulhern that all bills found to be true and accurate be approved.

- + Motion by Mrs. Selwood, Mr. Stark that the first reading of policy #115 entitled Career and Technical Education be approved for first reading.
- + Motion by Mr. Thorne, Mr. Strauch Dr. Mould be appointed Treasurer of the Lackawanna Trail School District for the 2015-2016 fiscal year at a corresponding stipend of \$600. + Motion by Mr. Mulhern, Mr. Clarke to close nominations for Treasurer.
- + Motion by Mr. Mulhern, Mrs Selwood that Denise Collins' resignation as Student Senate Advisor be accepted, with regret. Passed 6-1 Mr. Strauch voting NO
- + Motion by Mr. Clarke, Mr. Stark that Dr. Rajah Mulloth be approved as the school district physician for the 2015-2016 school year with a corresponding stipend of \$10,000.
- + Motion by Mrs. Selwood, Dr. Mould to officially suspend the boys' volleyball program for the 2015-2016 school year.
- + Motion by Mr. Thorne, Dr. Mould to eliminate the public relations director's position, effective at the end of the 2014-2015 school year.
- + Motion by Mr. Mulhern, Mrs. Selwood that the senior class's request to go on a field trip on Dorney Park in Allentown, Pa, on, May 29, 2015, be approved at no cost to the district.
- + Motion by Mr. Stark, Dr. Mould that Mr. Dalasio's request to take 5 students (stock exchange game winners) to the New York Stock Exchange on, May 15, 2015, be approved at no cost to the district.
- + Motion by Mr. Mulhern, Mr. Clarke that the proposed list of 2015 graduates be approved. Passed 6-1, Mr. Strauch voting NO because the Board has no discretion to approve or reject a list. Policy #217 states that "The Board shall award a high school diploma to every student enrolled in this district who meets the requirements for graduation established by this Board."
