All clearances are on file. Passed 7-1, Mr. Strauch voting 'NO' on the expense until the music teacher's position is restored.

- + Motion by Mr. Ross, Mr. Strauch that Debra Curmaci's request for unpaid leave on February 9, 2018 be approved. Passed 7-1, Mr. Thorne voting 'NO'.
- + Motion by Mr. Strauch, Mr. Stark that Tiffany Carpenter's request for un-paid leave on January 15, 2018 be approved. Passed 7-1, Mr. Thorne voting 'NO'.
