Regular Meeting

The Lackawanna Trail School District Board of School Directors met in their monthly meeting on Tuesday, October 12, 2010 at 7:30 p.m. in the board room, public notice thereof having been given in accordance with applicable law. The motion was approved by unanimous roll call vote 8-0.

Mr. Clarke made a motion, seconded by Mrs. Rigard, the tax claim settlement offer of \$20,000 on the Jerilyn Edwards Johnson/John Edwards Baylors Lake Road property, Benton Township, Tax I.D. No. 02902-010-001 as per the terms set forth in District letter from Solicitor Audi to Ronald J. Koldjeski, Lackawanna County Tax Claim Bureau, dated September 27, 2010, be approved. The motion was approved by unanimous roll call vote 7-0-1. (Mrs. Johnson abstaining)

Dr. Lombardi made a motion, seconded by Mr. Naylor, that the action of the Board Committee at the student disciplinary hearing in regard to student #13024 held on September 14, 2010 be approved, and that the adjudication in the matter of said student disciplinary hearing be ratified in all respects as the action of the Board of School Directors of the Lackawanna Trail School District. The motion was approved by unanimous roll call vote 8-0.

Mrs. Johnson made a motion, seconded by Mrs. Rigard, that Mary Belle Gilroy's request to take 80 Art students to New York City to visit the Metropolitan Museum of Art and the Guggenheim Museum on Thursday, November 18, 2010, be approved at no cost to the district. The motion was approved by unanimous roll call vote 8-0.

Mr. Naylor made a motion, seconded by Mrs. Johnson, that tabled motion #8 from the August 18, 2010 meeting entitled Unpaid Leave be removed from the table. The motion was approved by unanimous roll call vote 8-0.

Mrs. Richards made a motion, seconded by Dr. Lombardi, that Kelly Hopkins' request to take approximately 15 weeks unpaid leave commencing September 2011 through December 2011 be approved with the conditions that Mrs. Hopkins will accrue uninterrupted seniority, and will return to her position at the conclusion of the leave.  
The motion was approved by unanimous roll call vote 8-0.

Mr. Clarke made a motion, seconded by Mrs. Johnson, that Jay Travis be approved as a volunteer assistant band director for the 2010-2011 marching band season, all clearances currently on file. The motion was approved by unanimous roll call vote 8-0.

Mrs. Rigard made a motion, seconded by Dr. Mould, that the music department's request to take approximately 100 music students to Boston, Ma and surrounding area on May 12, 2011 through May 15, 2011, be approved, at no cost to the district.  
The motion was approved by unanimous roll call vote 8-0.

Mrs. Rigard made a motion, seconded by Dr. Lombardi, that the Sandy Spott's request to take approximately 35 learning support students to Radio City Music Hall for the Christmas Show on December 7, 2010, at no cost to the district, be approved.  
The motion was approved by unanimous roll call vote 8-0.

Dr. Lombardi made a motion, seconded by Mrs. Rigard, that the use of Lackawanna Trail School District property as a CDL training site be prohibited. The motion was approved by unanimous roll call vote 8-0.

Mr. Naylor made a motion to adjourn. So ordered.
