Unapproved, unofficial Minutes of the March 2, 2020 Lackawanna Trail School Board Meeting

The LTSD Board of Education had a meeting on March 2, 2020 @ 7:30pm in the Board room, public notice having been given in accordance with Pa.C.S.A. § 709 (Sunshine Act) & LTSD Procedure #006. The meeting began with a detailed discussion including various coaches as to the need for and concepts important to building a NEW FIELD HOUSE. This will benefit multiple athletic disciplines in the school. It is expected to be funded from an approximate \$2,000,000 capital projects budget item that already exists in the budget. This discussion lasted for about 40 minutes and is the beginning of discussions with the public about the need.

There was a presentation by the Senior Class officers as to the plan for and details of the requested Senior Trip to Six Flags New York. The expected cost per student is targeted at about \$75 for the overnight trip that will enjoy both the land and water park sections of six flags over a two-day visit.
